His Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Dust Diseases Tribunal Act 1989*.

Explanatory note

The object of this Regulation is to amend the Dust Diseases Tribunal Regulation 2013:

- (a) to increase certain fees payable in respect of proceedings before the Dust Diseases Tribunal, and
- (b) to increase (from \$14 or \$34 for different types of records to \$80 for any record) the fee payable for a standard retrieval request for retrieving and providing access to a file or box of files retrieved from an off-site storage facility so as to bring the fee into line with the fee charged by the NSW Civil and Administrative Tribunal for the same service.

This Regulation is made under the *Dust Diseases Tribunal Act 1989*, including section 34 (Regulations: Tribunal fees).
