- Email your completed form to the <u>NCAT Registry</u> managing your case as soon as you become aware that you want to attend by telephone or video. Check your Notice of Listing for email address details.
- NCAT considers each request on a case-by-case basis. Your matter might not be appropriate for a telephone or video hearing and your request might not be granted.
- If your request is granted, NCAT will tell you what you need to do to take part in the hearing by telephone or video. If the request is not granted, the hearing will go ahead in person even if the parties have agreed to the change request.
