1. Method

1.1. Search strategy

1.1.1. Academic database search

We conducted a systematic search of the following academic databases: PsycINFO, MEDLINE, Embase and Embase Classic, Social Work Abstracts, Education Resources Information Center (ERIC), Cumulative Index to Nursing and Allied Health (CINAHL), Applied Social Sciences Index and Abstracts (ASSIA), Sociological Abstracts, the Cochrane Library, and The Campbell Library.

The search was limited to the years 2000 onwards and to the English language. Syntax for PsycINFO via OVID is presented in table 1. This was converted for use with other database platforms as needed. Database results were exported and combined, and duplicate references were removed. Table 1 includes the search terms used to search OVID databases; this syntax was modified to search ProQuest and EBSCO databases.

1.2. Study selection

The following inclusion and exclusion criteria were used to select relevant studies from the results of the database searches:

1.2.1. Inclusion criteria

- Dated from year 2000 onwards
- English language

- Focus of study is case management for (or equivalent terms such as case coordination, conference or planning, service coordination or planning, multidisciplinary/interdisciplinary team, casework, whole of family, wraparound, team around the child, or teaming structure)
- Target of the case management is vulnerable families
- Controlled study design including randomised controlled trials, well-formed evaluation studies with both pre- and post-data and a control group, prospective longitudinal studies, systematic reviews and meta-analyses

1.2.2. Exclusion criteria

- Dated prior to year 2000
- Non-English language
- Book, thesis, chapter, or conference proceeding
- Uncontrolled or qualitative-only study design
- Target of case management is adult only with no family involvement (for e.g. case management for medical or psychological condition such as heart disease or alcohol or other drug use).

NB: eligibility is restricted to studies where case management was the focus (for example, comparing case management to services as usual, or intensive case management models to case management as usual). Therefore, studies where case management was reported as a component of a larger intervention (but was not the primary focus of the paper) were excluded.

1.3. Data extraction

For each eligible study, information relating to case management methods, personnel, resources, and outcomes was extracted to spreadsheet tables under the following categories: case management for families receiving targeted prevention and early intervention services, case management for families receiving intensive services, and case management in services for young people aged 12 and over. Where a study could have been classified to more than one category, it was included in the category which reflected the main focus of the study.

In extracting data, emphasis was given to obtaining information on the intervention as delivered in practice, rather than to the theoretical focus or development of the intervention.

1.4. Data analysis and synthesis

A narrative analysis of major case management components is presented. The overall effectiveness of case management interventions is reported separately (restricted to a discussion of significant changes to outcomes for children and families) in order to give a sense of the general strength of evidence in relation to this field. It is not possible to report on the effectiveness of individual constituents of case management.

2. Results

2.1. Search results and included studies
